

## RIVER RIGHTS KORNER

Mr. Benny Young, owner of Twin Oaks Camp and Canoe Livery, was arrested on Armuchee Creek Sat. Aug. 18, 1990 for criminal trespass. Armuchee Creek is a beginner flat water creek, north of Rome, Georgia in Chattooga County. Benny has owned the camp and canoe livery for the last six years. A local landowner (Mr. Ralph Henry), who owns land on both sides of the river, has told Benny that he can't float through "his" property. Mr. Henry has strung electric wire across the stream to keep his cows inside, however in the process of trying to contain his cows, shocked both Benny Young and one of the Rome Boys Club leaders. Benny has offered many times to install and pay for a floating gate for Mr. Henry, but was turned down by Mr. Henry. The Chattooga County sheriffs department and the State Fish and Wildlife Department detained 17 members of the Rome Boys Club and was going to arrest the boys until Benny talked the them into arresting him instead of the children. Benny has been charged with criminal trespass (for floating in the water, neither he nor the boys were on the land) and has a court date for Oct. 8. 1990.

GCA has joined Benny Young in a civil lawsuit against Mr. Henry. The attorneys for the lawsuit are Gavin Appleby and Craig Pendergast of Paul, Hastings, Janofsky & Walker (for those of you who were club members during the Smith Island lawsuit of three years ago, Gavin and Craig were two of our attorneys). Gavin and Craig need to find persons who have paddled Armuchee Creek any time in the past. IF YOU HAVE PADDLED THIS CREEK OR KNOW OF ANYONE WHO HAS, PLEASE CALL: Carol Mercer, River Rights Chair, at 373-6683.

GCA will be having a fundraiser to help pay for the costs of the lawsuit. Stay tuned to your Eddy Line and your mail box for further details.

I have discovered that the new gauge on the Tellico (which was mentioned in the September Eddyline) gives the reading in <u>feet</u>, not cfs as I had originally been informed. There will be four beeps corresponding to the appropriate digits for the tens, ones, tenths, and hundredths of feet at the gauge. Since the Tellico gauge will usually the under 10 feet (fortunately), the first beep will usually be a long one indicating zero for the tens of feet reading. If the gauge reading were 2.62 (about 600 cfs), the long beep would be followed by a pause, then two short beeps, another pause, six short beeps, a third pause, and finally two short beeps. The phone number, 615-253-7951, is for the actual gauge on the river in Tellico Plains. This addition of this phone gauge should make catching the Tellico a whole lot easier.

THIRTY YEARS MESSING ABOUT IN BOATS. I'm no old timer by GCA standards, but September 1990 marks the end of my 30th year on the rivers. I've tried all the commoner forms of human-powered river transport, rowing, canoeing, poling, and now kayaking. I began in rowing shells at M.I.T., and we raced on the Charles, the Connecticut, the East off Manhattan, etc. In Philadelphia I sculled on the Schuylkill, and in '66 took a couple of gals out in a canoe. It was a strangely non-directional experience. Later I traded my scull for a motorcycle (I was lucky not to land on my scull instead), married, and canoed briefly with Ellie on the Delaware Water Canal on our honeymoon. I'm sorry we didn't paddle the Delaware proper.

Off to Oregon in '70, we saw a lot of great rivers, but our time on the water comprised a rowboat paddle on Crater Lake and a jet-boat tourist trip up the lower Rogue. When we moved to Lexington, KY in '72, there wasn't as much spectacular hiking as in the west, but we ran into some folks from the Bluegrass Pack and Paddle Club, bought an 18.5 foot fiberglass supercance, and began paddling on the Kentucky, the Licking, the Red and the Green. We attempted a titanic 13 day Quetico trip, but found it was just too much; we spent most of the time on Agness Lake.

Paul was born in February, '74, and I bought a 13' Mad River Compatriot for personal paddling. I got whitewater instruction on Indiana's Whitewater River and on KY's Rockcastle. Once we knew we were moving to Atlanta, I joined the GCA, and by June I was on the Etowah and Upper Hooch, finding the Compatriot a real challenge in serious whitewater.

In late summer I bought my first C-1, a Crowley Hahn. I took my first and last swim below Lesser Wesser, and by '76 when Sarah was born, I was leading trips and exploring rivers. "Mommy, that strange man is at the door again." In November, '78 I began my tenure as GCA newsletter editor, which will end with the next issue. In the vintage highwater season of '79, I enjoyed epic runs with Jack Weems, Ken McAmis, Bronwyn Fowlkes, Hank Klausman, etc., and if my skills were not so great then, my roll was strong. Maybe that was my peak paddling period; I'm not sure. It's always all downhill on the rivers.

Now I have two kayaks, one C-boat, the old Compatriot, a Tripper, and the old supercance, which is in mothballs. I have a wife who prefers "Ellie" rivers (scenic and easy), a son still slightly interested in paddling, and a daughter who refuses to consider it. I am almost 48, my old buddies have sold their decked boats, and I should do the same, but three weeks ago I rolled the kayak below Lesser Wesser, and I'm hoping for at least a decade more of serious whitewater.——Your old editor, Gary DeBacher

ARCANE KAYAKING LORE. I was just discussing kayak designs with another very large kayaker, and we agreed that boats for big men are still a problem. Perception rates handling as excellent for my Dancer XT with a 200 lb load, but I can only say that it is in some ways distinctly inferior to my C-1. The problem, as I see it, is that with the standard 24.5 inch kayak width, and a short, rockered, hull, the XT sits rather deep in the water and mushes around. A nonsquirt boat needs to be somewhat up on the water for optimum handling. Perception may have recognized this when they designed the Corsica, which has a 25.5 inch width and a flattish bottom. If designers are serious about k-boats for really heavy paddlers, they need to consider making them a little longer and wider than standard playboats. The Jeti Grande was an example: designer Vanha simply spliced an extra inch of width through the length of the hull.

Of course you don't often see someone 6'5" and 200 lbs trying to fit into kayaks, but I've seen worse. John Helmlinger, GCA president back in the middle 70s, was fractionally taller, bigger in frame, and about 20 lbs heavier than me. There were no commercial kayaks big enough for him then, so he took a Crowley Hahn C-1 and installed a kayak cockpit. It seemed to work pretty well for him.

It isn't that hard to convert a "glass" C-1 into a kayak. I just got done converting a CAP/Kevlar Noah which I bought for only \$100. This model was sold both as a K-1 and as a C-1. Hal Herndon used to have the kayak version, which he found fast-handling but edgy and hard to roll. Those who owned the C-1 version hated it: the flat bottom, slab sides and 24.5 inch width made it treacherous!

My conversion procedure was fairly complex, and not of enough interest to relate in detail, but for the few of you who still work with resin and cloth, I would be glad to share my experience on such matters as measuring the boat for walls, laying out a cockpit, cutting the cockpit, using the vinyl tube and hot glue method to lay up a rim, fitting and gluing the walls, installing braces, and making a minicell seat as an alternative to a hanging seat. The wonderful thing about "glass" boats is that they are so modifiable and repairable. Wallbridge covers most of these topics fairly well, though in each case I found important details which needed working out.

The resulting boat has a giant keyhole cockpit with 3" minicell walls and splay-legged full thigh braces, a combo which is hard to find in a big man's kayak. It weighs 32 pounds with bags, distinctly better than my 41 lb XT. I am probably 20 lbs too heavy for the hull design, but it turns high and firm into eddies, ferries like dynamite, and surfs waves well. It is hard to roll. I don't intend to beat it to death on the Ocoee, but it should make a great fat man's citizen racer. You think you've seen boats with rails? Wait til you see this one. ---Gary DeBacher
